

Conflict of Interest Policy

The aim of this policy is to protect both YFYFC and individual Members from any appearance of impropriety and follow guidance set out by the Charity Commission 2020.

Members have an obligation to act in the best interests of YFYFC and in accordance with its charitable status. Conflicts of interest may arise where a trustee, officer or members personal or family interests and/or loyalties conflict with those of YFYFC.

Such conflicts can inhibit free discussion, result in decisions or actions that are not in the interests of YFYFC, and risk the impression that YFYFC has acted improperly.

Common conflicts of interest can include: Financial conflicts or loyalty conflicts.

Declaration of Interests

Conflict of Interests Procedure

- If a member or their family faces a conflict for a commercial or business-related reason, they must not engage in decisions that affect them. They must declare their interest at the earliest opportunity and withdraw from any subsequent discussions.
- Conflicts of interest must be recorded in the minutes.
- In the event of the Committee having to decide upon a question in which a member has an
 interest, all decisions will be made by vote, with a simple majority. A quorum must be present
 for the discussion and the decision. Interested parties will not be counted when deciding
 whether the meeting is quorate. Interested members may not vote on matters affecting their
 interests.
- Trustees and County Officers must signed a declaration of interest (attached) at the start of their tenure and this should be renewed annually.
