Emergency exits comply to legislation and are kept clear at all times. Any dangerous ground surfaces must be appropriately reported to the venue owner. If necessary, the YFC Chief Steward will use a physical barrier or hazard tape to warn others of the risks. Steward to remove anything that could cause trips, slips, and falls on the pitches. The Chief Steward and Referee will check over the sports pitches (grass/astro turfs) prior to the commencement of the game. The Referee is to pass the pitch fit for play and the decision rests with the Referee should weather conditions worsen and the pitch becomes unplayable. All animal faeces, sharp objects and litter should be removed before commencement of play. Competitors will have received sufficient sports practice within clubs/districts and therefore be aware of the competition's expectations and rules. Competitors will be supported during the competition by the stewards and those competitors under the age of 18 years will be able to speak to a parent/responsible adult such as a Club Leader before and after the competition for any wellbeing support required. If a competitor feels they would like additional support to manage stress and anxiety they will be able to contact the YFYFC Designated Safeguarding Officer after the event or access the YFYFC website for self-lead support via the member welfare webpages. The Referee will check for any inappropriate footwear. Badminton players to wear badminton shoes or non-marking trainers (black soles are not permitted). Rounders players are to wear appropriate sports footwear. Netball players are to wear appropriate sports footwear. Football players are not permitted to wear screw in or studded footwear or blades. Only training shoes, moulded soles and astro boots may be worn. The wearing of any form of jewellery (including, without limitation, watches) is not permitted during play of any sport. Referees may refuse to allow members to play with inappropriate footwear and/or are wearing any form of jewellery. Members are expected to play 'in the spirit of the game'. Team Captains are responsible for the appropriate behaviour and actions of the members. All members must abide by the Referee's decisions. Team Captains to communicate with any member who appears to be behaving in an anti-social manner that puts others at risk. Members should warm up and cool down properly before matches and training. YFYFC is responsible for ensuring first aid is available and will have access to a fully charged mobile phone in the event of contacting the emergency services (ambulance). YFYFC have contracted a first aid provider to manage the first aid provision.
